



The 7 magic steps to Linear Programming:

1. Define your variables
2. List your constraints (write your inequalities)
3. Graph your inequalities, defining your feasible region
4. List the vertices of your feasible region
5. Write a profit or cost equation
6. Create a profit or cost table with your vertices
7. Place your final answer in a complete sentence
